

## Travel Contract – FULL SERVICE General Terms and Conditions



Concluded between:

as the Private Guest of LGW (hereinafter LGW Guest),

For the services specified below and under the following terms and conditions:

1. Travel to Northern Hungary organized by LGW shall be in accordance with the International Convention on Travel Contracts (Brussels, 23 Apr 1970).

### 2. The Contract

This travel contract, concluded between the LGW Guest(s) and LGW takes effect upon signing by both parties and payment of the deposit. If the travel booking is arranged by an authorised representative of the LGW Guest (possessing a lawful authorisation to act on the Guest's behalf), who duly pays a deposit and signs a travel contract, the consigner (LGW Guest) becomes subject to all rights and obligations stemming from the travel contract. LGW is obliged to forward all obtained documents and information to the consigner.

### 3. Travel Documents

The LGW Guest shall obtain a valid identity card or passport necessary for travel. LGW does not take any responsibility for any loss and expenses incurred if the LGW Guest is not in possession of a valid identity card or passport. Hungary is member of the European Union, therefore a valid identity card is enough for travelling.

### 4. Insurance

We advice you to have full health insurance, including additional hospital and medical insurance. Thus we highly recommend that you review your health and personal insurance to meet the needs of yourself and your family in case of any loss of property, accident or injury while on the trip.

### 5. Participation Fee

The participation fee – if not stipulated otherwise – includes the return flight ticket (incl. taxes and charges) and accomodation (in hotels\*\*\*/\*\*\*\*); the procedural duties, organizational and administrative costs of LGW, tour guiding in English (or other requested languages), 24-hour standby fee, and value added tax. Certain hotels have discount prices for children, therefore participation fee may reduce for children aged 0-12 by the amount of discount the hotel offers.

LGW Guests may change the set programs issued by LGW according to the conditions concluded in the LGW program brochure.

### 6. Deadlines for the Payment of Deposit and Participation Fee

The deposit must be paid upon the signing of the contract by bank transfer (see bank details at the bottom of paragraph). The deposit equates to 50 percent of the whole participation fee. Having received the deposit, LGW sends the LGW Guest a proof of receipt. The payment of the remainder must be paid by bank transfer to the joint account opened for this reason by the President and the Founder of LGW. The payment must reach LGW's account at least 20 days prior to departure.

As soon as the amount arrives to the above account, LGW issues an invoice of the whole participation fee and posts it to the address of the LGW Guest. In case the LGW Guest does not fulfil his/her obligations to pay the participation fee in full prior to prescribed payment deadline, LGW may withdraw from the contract without notice regarding the travel as cancelled, and the LGW Guest loses the amount of the deposit.

The LGW Guest acknowledges that services provided by the airlines are subject to intermediate and unplanned landings and change of plane and/or airline is possible without prior notice. Luggage weight is limited to 20 kg on flights. Overweight is allowed on flights that may levy an extra fee for this.

**7. Cancellation by LGW Guest**

If you wish to cancel your holiday in whole or in part after your booking has been confirmed, you should inform us in writing as soon as possible. If you do cancel we reserve the right to charge a cancellation fee on the following scale:

Amount of notice you give us before the scheduled departure date	Amount of cancellation fee (expressed as % of holiday price)
More than 29 days Deposit	Deposit
15-28 days	60% of TOTAL cost of holiday
7-14 days	80% of TOTAL cost of holiday
1-6 days	100% of TOTAL cost of holiday

No refunds are made by us for cancellations made on or after the date of departure. We strongly advise you to take advantage of travel insurance which includes protection against cancellation charges.

No refund will be granted to participants who do not show up at departure, or who are unable to embark on the journey because of absent, invalid or inadequate personal documents for leaving the country or who decide not to carry on with the journey.

Please note that we will retain €30,00 from any money refund due to administrative and bank transfer costs.

**8. Changes or Cancellation by LGW**

We will make every effort to provide your holiday as booked, but we reserve some rights to make changes or even cancel if necessary for the LGW Guests' security and own good. Up to six weeks before the departure date we reserve the right to change or cancel at our discretion. In this event, we will offer you an alternative holiday of at least comparable standard, if available, or if you prefer we will refund all the money you have paid. We shall not be liable for any drawbacks due to a result of unusual and unforeseeable circumstances beyond our control such as strikes, war, civil or political unrest, etc, usually known as 'force majeure'. In case of cancellation made by LGW due to unforeseeable circumstances beyond our control, we will refund all the participation fee that will be refunded to us by the airline and hotels.

9. LGW's Responsibility

We have taken care in choosing the accommodation and other services and facilities included in the holidays we offer and we have described them in the LGW program brochure in accordance with the latest information we have at the time of publication. We will notify you of any changes when you make your booking. We accept responsibility for ensuring that all elements of your holiday which we are contractually obliged to provide are as described in the LGW program brochure and are of reasonable standard. We do not accept responsibility for any loss suffered as a result of any event beyond our control.

10. Modification of the Contract

The LGW Guest, for his/her own comfort, can modify certain elements of the travel contract (e.g. alteration or omission of the name of the participant, hotel reservation, additional services) free of charge.
